### REGISTRATION GUIDELINES

1. Children are admitted to class when the Faith Formation Office has received each student's completed registration form and fees. A return envelope is enclosed for your convenience.  
**NOTE: Payment in full is due at time of registration. Questions? Contact Ginny Grogan at 667-2440 x347. Registration forms received without payment cannot be processed nor the student(s) placed in class.**
2. A valid copy of a child's Baptismal Certificate must accompany a first time registration form.
3. Families who are registering students as transfers from another Faith Formation program or Catholic school must include a letter from the transferring parish/school affirming the child/children's consistent attendance.
4. Families are expected to be registered members of the Catholic Community of Christ Our Light. Please check the parish website [www.christourlight.net](http://www.christourlight.net) for parish registration information.
5. Families should be participating in the sacramental life of the Church by attending weekly Mass.
6. Home Schooling may be considered when a family is experiencing circumstances that prevent weekly class attendance. Please call the office to discuss your child's need to Home School and our parish Home School policy. All forms and fees apply.
7. Parents / guardians who have joined the catechetical ministry and teach weekly in our Elementary/Youth Faith Formation program during the school year, who attend catechist meetings, and participate in regular Sunday worship do not pay a registration fee.
8. Fees for children enrolled in Sunday morning **Pre-K – K classes are \$45.00 per student**
