Reading for May 10, 2020

John 14:1-12

#### Adults:

How are the promises of the Gospel passage made real in your own life, even in the midst of difficulty and crisis?

We offer this form of *Lectio Divina* (sacred reading) for pondering Scripture and for faith sharing with family members and other people.

- Listen/ Read (*Lectio*): Ponder God's word and listen for what touches your heart.
- Meditate (*Meditatio*): Attend to what you notice. Allow God's word to resonate in you.
- Speak/Share (*Oratio*): Prayerfully share with Jesus or with the group your thoughts and feelings.
- Rest in God's presence (*Contemplatio*): Notice God's presence and be still, surrounded by God's love.
- Choose to act (*Actio*): Trusting in God's nearness, commit to action rooted in love.

#### Teens:

What do you think are the most important things in life?  
What does Jesus say are the most important things in life?

#### Children:

What are some ways you can imitate Jesus when you're home with your family?

Donations can now be made to Christ Our Light via TEXT TO GIVE

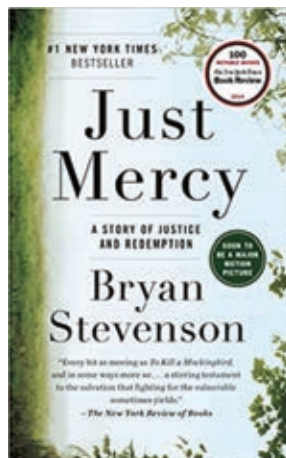
If you have a Parish Giving Account already set up with your mobile phone number registered, just Text (856) 363-3383 with a dollar sign followed by the amount you would like to donate,

for example, \$25. You will get an immediate response confirming your contribution to Christ Our Light. Additionally, you will receive an email when your transaction is processed. The email will be your receipt for the transaction.

If you do not have a Parish Giving account, just Text (856) 363-3383 with a dollar sign followed by the amount you would like to donate, for example, \$25. You will receive a prompt to sign up for an account with the link provided. Once you provide your contact information and either credit/debit card or bank information, along with your email address and phone number you will be all set up. The process takes about 2 minutes! Then you can text a dollar sign followed by the amount you would like to donate and you will receive a response confirming your contribution to Christ Our Light.

### *Future First Communion Celebrations!*

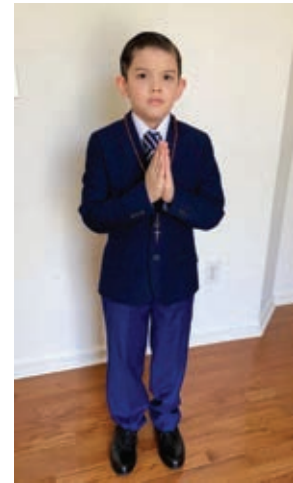

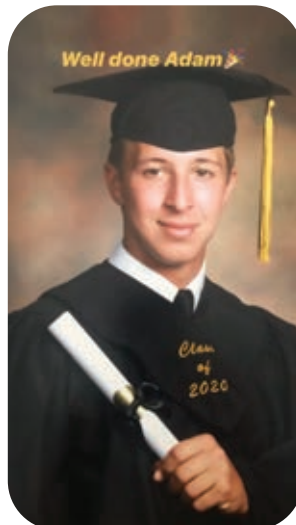
